KZNMPF Disability Benefits

As a member of the fund, you have access to disability benefits paid for by your employer. To help you if you become disabled while still working. These benefits can provide essential financial support when you need it most.

The fund offers two types of disability benefits:

1. Temporary Total Disability (TTD)

Members may receive temporary or permanent disability benefits. For temporary disability, the process starts after being temporary boarded off work for over 3 months due to illness or injury.

*This is the waiting period prescribed by employer where you are paid from your accumulated leave.

After this, if TTD is approved your payroll shifts to the Fund's Temporary Total Disability (TTD) program, which pays 75% of your salary for up to 21 months. The 25% shortfall must be covered through personal savings, lifestyle adjustments, or if available leave encashment. This is after the continuous assessment is complete - where the continuance of disability report form (COD) is completed by the member's treating doctor.

2. Permanent Total Disability (PTD)

The assessment for PTD is done after the member complete 21 months of TTD. A permanent total disability claim must be approved by the employer, once the recommendation has been sent by the Fund.

PTD process is characterized by the following points:

- Members can only go on PTD once they have completed the TTD program.
- Initial Claim forms (CMR) state the member needs to go straight to PTD.
- Submission of the Comprehensive Medical Report.
- 21 Month TTD period does NOT guarantee PTD admission.


